PART IV: NARRATIVE INTERPRETATION OF ABOVE STATISTICS

1. Crime trends/problems (Gangs, Drugs, Domestic Violence, Traffic etc.)

There were a total of 20 files created in the month of February. This includes both calls from the public and self-generated matters.

There were seven reports of mischief over the month. It should be noted that the offence of Mischief also includes obstructing enjoyment of property.

There were four issues of intoxicated people causing issues at people's homes. There was a broken rear window on a truck. People going through a yard and a group of youths damaged the Denare Plex.

One break and enter was reported. The person or persons involved seemed to go right to specific property. This is still on-going.

One theft of a truck. The truck was recovered and charges laid. The matter is still before the courts.

In the "Other Criminal Code" category we saw a Telemarketing scam and Possession of Property Obtained by Crime and breaches.

In the "Other" category we saw a false alarm, a suspicious person and found property.

2. check stops, curfew checks, interagency/ meetings etc. (Indicate dates, locations, members that attended etc.)

Creighton Detachment is committed to providing a quality policing service to Denare Beach.

3. Feed Back on Police Management Board Meetings/Community Consultative Groups / Justice Committees etc. (positive/concerns/questions/other)

Creighton Detachment area currently has no Community Consultative Groups/Justice Committees, or Community Police Boards. We do take part in an inter-agency committee and are part of a working group trying to bring the HUB concept to our area.

4. Other significant issues: (Infrastructure/Human Resources/Change of Chief and/or Council)

Creighton RCMP is fully staffed at 6 positions, 1 Sgt, and 5 Csts. Currently the detachment is running at 2 members short. We hope to have another member in place in the near future.

5. Document feedback (positive/concerns/questions/other) from Town and Council Sgt MCPHEE has not had any negative comments. The village would like to see the detachment continue to apply pressure to offenders.

6. APP update to community

The goals of the APP are on track, the goal of 400 curfew checks is on track and the detachment has done another 61 in the month of February. This gives us a total of 744 for the fiscal year. The priority remands are now at 18 having completed 2 in February.

The traffic initiative continued. The detachment conducted more traffic stops and wrote one vehicle defect ticket. This gives the detachment 26 for the year. Check stops remain at 7.
